SUPPLY OF LABOR AND MATERIALS FOR THE CENTRALIZATION OF POWER SUPPLY FOR ALL BGHMC BUILDINGS AND REPAIR/RENOVATION OF FLAVIER BUILDING

1. The Baguio General Hospital & Medical Center (BGHMC) through the Government of the Philippines (GOP) intends to apply the hereunder amount for each project being the Approved Budget for the Contract (ABC) to payments for the following Hospital Infrastructure projects.

2. The BGHMC now invites bids for the above stated projects . Completion of the Works are required within **One Hundred Eighty (180)** calendar days for the Centralization of Power Supply for all BGHMC Buildings & **Two Hundred (200)** calendar days for the Repair/Renovation of Flavier Building . Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. When the foreign supplier is a citizen, corporation or association of a country, the laws or regulations of which grant reciprocal rights or privileges to Citizens Corporation or associations of the Philippines.
4. Interested bidders may obtain further information from BGHMC and inspect the Bidding Documents at the Bids and Awards Committee Office from Monday to Friday from 8:00 a.m. – 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on August 19, 2015 at the BAC Office from address below and upon payment of nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos (Php 25,000.00)**.

5. The BGHMC will hold a Pre-Bid Conference on **August 28, 2015, 10:00 A.M.** at the **BGHMC BAC OFFICE**.
6. Bids must be delivered to the referred person and address below on or before **September 8, 2015, 12:00 P.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Section III Bid Data Sheet Clause 18.1.

Bid opening shall be on **September 8, 2015, 2:00 P.M. at the BGHMC Dietary Hall, 2nd Floor Main Building**. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address as stated. Late bids shall not be accepted.

7. The BGHMC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
