KNOW ALL MEN BY THESE PRESENTS

This Contract entered into by and between;

BAGUIO GENERAL HOSPITAL AND MEDICAL CENTER, a government hospital duly established in accordance with law, with address at Governor Pack Road, Baguio City, represented by its Medical Center Chief, **RICARDO B. RUNEZ, JR., MD, FPCS, MHA, CSEE** hereinafter referred to as the **"FIRST PARTY"**.

- and -

MEDISAFE PHILIPPINES, INCORPORATED, a company duly incorporated under the laws of the Republic of the Philippines with address at **Suites 303 & 310 West City Plaza Building, #66 West Avenue, West Triangle, Quezon City**, herein represented by its Authorized Representative, **MANUEL SOLIVERES**, hereinafter referred to as the **"SECOND PARTY"**.

Witnesseth:

WHEREAS, the **FIRST PARTY** has announced its need to purchase of **PROCUREMENT OF VARIOUS COMMON COVID-19 MEDICAL SUPPLIES UNDER BAYANIHAN ACT 2 (IB No. BAC II 2020-012)** through public bidding so as to meet the exigencies of the service as follows:

WHEREAS, the **SECOND PARTY** was among those who participated in the bidding for the supply and delivery on the **PROCUREMENT OF VARIOUS COMMON COVID-19 MEDICAL SUPPLIES UNDER BAYANIHAN ACT 2 (IB No. BAC II 2020-012)**.

WHEREAS, after post-qualification prescribed under Sections 34 and 36 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the bid offered by the **SECOND PARTY** was found to be the Single Calculated and Responsible Bid;

WHEREAS, after due proceedings, the offer made by the **SECOND PARTY** was declared Responsive in all aspects and was thus awarded the contract;

NOW, THEREFORE, for and in consideration of the foregoing, this Agreement is entered by and between the **FIRST PARTY** and the **SECOND PARTY** with the following covenants, to wit:

GENERAL PROVISIONS:

1. The **SECOND PARTY** shall perform his/ its obligation to supply the item/s prescribed in the bidding on the **PROCUREMENT OF VARIOUS COMMON COVID-19 MEDICAL SUPPLIES UNDER BAYANIHAN ACT 2 (IB No. BAC II 2020-012)** in accordance with its offer as stated in the Bid Documents it submitted and which was accepted by the **FIRST PARTY**.
2. The **FIRST PARTY** shall pay the **SECOND PARTY** the contract amount of *One Million Seven Hundred Twenty Seven Thousand (Php 1,727,000.00) Pesos* equivalent to the goods delivered as stated in the accepted offer submitted by the **SECOND PARTY** to the **FIRST PARTY**.
3. The following documents shall be deemed to form and be read and construed as part of this Agreement:
 - a) Bidding Documents;
 - b) Notice of Award dated November 16, 2020
 - c) Performance Security
 - d) Bid Bulletin
4. The goods subject for delivery shall be covered by the provisions of Republic Act No. 9184 and its Revised Implementing Rules and Regulations.
5. Any delay in the delivery shall be governed by Section 68 (Liquidated Damages) of the Revised Implementing Rules and Regulations of RA 9184.
6. Taxes and other government requirements on Government Money Payments Due or payable are shouldered by the **SECOND PARTY**.
7. The Obligations and rights arising from this contract shall not be assigned and transferred by the **SECOND PARTY** to any third party without the consent of the **FIRST PARTY**.

All terms and conditions as stated in all Bidding Documents are automatically reproduced as part hereof.


